Declaration and commitment of the Bidder and Foreign Planner

We, the undersigned _____ I.D. _____ (the "**Bidder**"), who submits a bid as part of tender No. 42/24 (the "**Tender**") of Ayalon Highways Company Ltd. (the "**Client**") and _____ I.D / registration No. _____ (the "**Foreign Planner**") hereby declare and confirm as follows:

1. The Bidder and the Foreign Planner entered into a cooperation agreement for the provision of planning services in connection with the Tender, which will enter into force no later than when the Bidder is announced as the winner of the Tender.
2. The Bidder and the Foreign Planner undertake, jointly and severally, that if the Bidder's proposal wins the Tender and a contract of engagement is signed between the Bidder and the Client, the Foreign Planner will be part of the Bidder's team for the project, and for the Client, will constitute the "Foreign Planner", as defined in the Tender, on behalf of the Bidder, and will give the set of services for the Client required from the Foreign Planner, in accordance with all the conditions and obligations detailed in the Tender documents, including the agreement on its appendices.
3. We declare that all of the above provisions are fulfilled in the agreement signed between the Bidder and the Foreign Planner ("**the services agreement**") in an unreserved manner, and will continue to be so, throughout the contract period between the Client and the Bidder, that the services agreement includes all the obligations of the Bidder towards the Client, with regard to the Foreign Planner, that any change in the services agreement is subject to the prior written approval of the Client, and that with the exception of the services agreement, which will be delivered to the Client at his request, without any deletion, amendment or change of any detail therein, there is no agreement, addition, appendix or other or additional agreements in connection with the Tender or the project mentioned therein.
4. We confirm that the services agreement does not include or will not include any instructions that contradict what is stated in the Tender, that we know that the obligations stated in this document are a condition for the Bidder's winning the Tender, and entering into a contract with him, and that the aforementioned does not affect the Bidder's winning the tender and/or the provision of services by the Foreign Planner on behalf of the Bidder within The provision of the services according to the agreement attached to the Tender, in order to create a direct or indirect obligation of the Client towards the Foreign Planner.
5. There is no impediment to the Foreign Planner's contracting in the services agreement and/or there is no impediment to the supply of Foreign Planner's services to the Client through the Bidder.
6. We also agree that, in the event that the contract between the Bidder and the Client is terminated or canceled for any reason whatsoever, then the Client will be entitled to receive the services that are the subject of the Tender, insofar as they are required from a foreign planner, directly from the Foreign Planner, while the Client directly pays the Foreign Planner the consideration for these services, without the Bidder having any claim or demand in the matter, and without the Client being obligated to continue the contract with the Bidder or pay him anything for it. A provision in this form is stated in the services agreement, and it precedes and prevails over any other agreement between the Bidder and the Foreign Planner.
7. The Bidder explained to the Foreign Planner all the instructions of the Tender, its documents and conditions, as well as all the obligations of the Bidder according to the Tender. The Foreign Planner on behalf of the Bidder read and reviewed the instructions of the Tender, its documents and conditions, understood them, and confirmed that they will apply to him, as far as the Bidder is declared the winner of the Tender.



8. The proposed Foreign Planner on behalf of the Bidder confirms that he is not proposed for the purpose of providing the services of the Tender by any other Bidder in the Tender.
