## E-Tender (Online) No. 15/21 A Framework Tender for the Supply, Integration, Operation and Maintenance for a MTMS (Metropolitan Traffic Management System) and its Modules (the "Tender")

## Clarification Notice no. 8

Ayalon Highways Co. Ltd. (the "Company") is hereby publishing a clarification to the Tender Documents, as follows.

- 1. The Deadline for Submission of Proposals is extended until October 14, at 15:00 PM (local Israeli Time).
- **2.** Answer no. 8 in Clarification Notice no. 7 (relating to the demonstration of experience required by the threshold conditions of Sections 8.4 or 8.5 of Document A, via related entities of the Bidder) is hereby amended as follows:
  - a. A Bidder (or a member of a Bidder in Category A, if the Bidder is a Joint Venture and in such case a reference to the Bidder in this clarification shall mean to such member of the Bidder), may demonstrate the experience required by the threshold conditions of Sections 8.4 or 8.5 of Document A, via one or more Related Entities, provided that the Bidder submits as part of its Proposal: (a) the declaration and undertaking attached as **Appendix A** to this notice, after being duly executed by such Related Entity and the Bidder, and (b) a holding structure diagram specifying all holdings, direct and indirect, connecting the Bidder and the Related Entity.

A "Related Entity" is any legal entity which Controls the Bidder (a "parent-corporation"), or is Controlled by the Bidder (a "subsidiary"), or is Controlled by an entity that also Controls the Bidder ("sister-corporation").

"Control" means holdings, directly or indirectly, of more than 50%.

- b. Only a Bidder is allowed to demonstrate its compliance through a Related Entity, and for threshold conditions 8.4 or 8.5 only (**not** for threshold condition 8.6(ii)). If the Bidder meets the threshold conditions of Section 8.4 or 8.5 via a proposed subcontractor, such proposed subcontractor must meet the threshold conditions itself (and not through a Related Entity).
- Appendix 7 of Document A, is hereby amended accordingly, and attached as Appendix B to this notice. Bidders (especially those relying on a Related Entity), must take care to submit this amended Appendix 7 with their Proposal.

This document is integral part of the Tender Documents, and the Participant is requested to attach a signed copy thereof to its Proposal.
